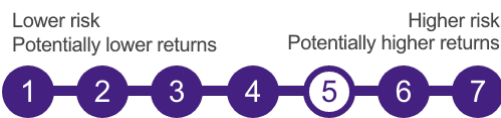
Description of this fund

A diversified fund that primarily invests in international equities, with a moderate allocation to Australasian equities. Objective is to maximise capital growth*over the minimum recommended timeframe.

What are the risks of investing?

Risk indicator for the GoalsGetter Milford Aggressive Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund’s assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Example of how this applies to an investor

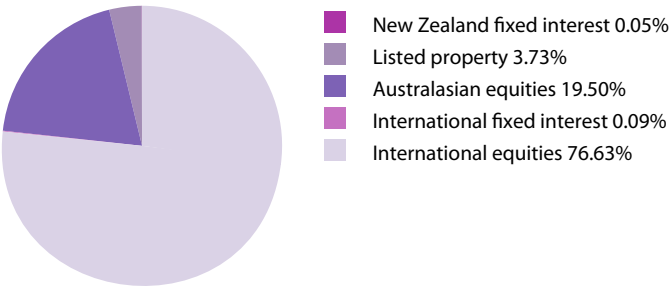
Small differences in fees and charges can have a big impact on your investment over the long term.

Sam made the first investment of \$10,000 in the fund at the start of the year and did not make any further contributions. As at 30 September 2025, Sam received a return after fund charges were deducted of \$401 (that is 4.01% of his initial \$10,000.00). Sam also paid \$7.50 in other charges. This gives Sam a total return after tax of \$384 for period ending 30 September 2025.²

Notes

1. Because the fund is less than five years old, the risk indicator uses returns data partly from returns of the fund, and partly (for the period October 2020 - June 2025) from the composite index.
