What is the purpose of this update?

This document tells you how the Amova ARK Disruptive Innovation Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. 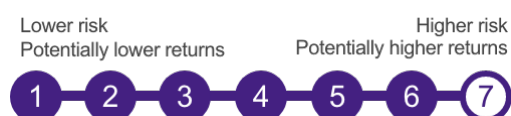
Description of this fund

The fund aims to outperform the benchmark of an absolute return of 10% per annum over a rolling five-year period before fees, expenses and taxes. The fund provides access to a global share portfolio that offers thematic exposure to disruptive innovation across a number of sectors, and geographies.

What are the risks of investing?

Risk indicator for the Amova ARK Disruptive Innovation Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

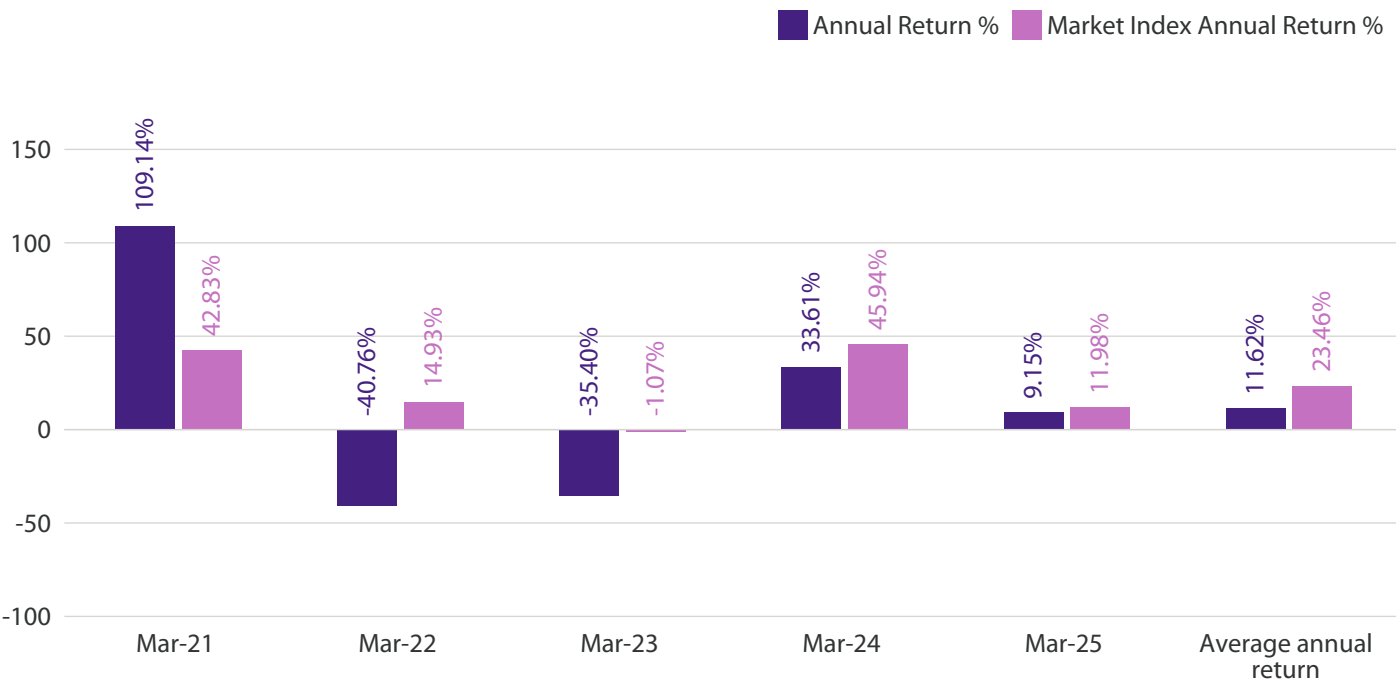

How has the fund performed?

Example of how this applies to an investor

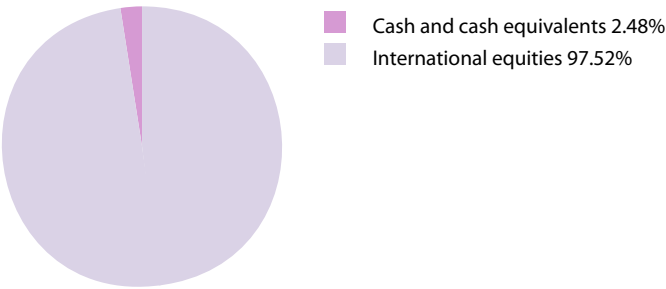
Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam received a return after fund charges were deducted of \$8,275 (that is 82.75% of his initial \$10,000.00). Sam also paid no other charges. This gives Sam a total return after tax of \$8,093 for year.²

What does the fund invest in?
