What is the purpose of this update?

This document tells you how the Amova Global Shares Hedged Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. 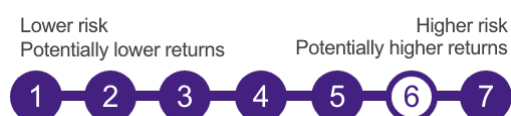
Description of this fund

The Fund aims to outperform the MSCI All Countries World Index, with net dividends reinvested, gross hedged 100% to NZD by 3.0% p.a. over a rolling three year period before fees, expenses and taxes. The Fund seeks to provide investors with a relatively concentrated actively managed investment portfolio of global equities to achieve long term capital growth.

What are the risks of investing?

Risk indicator for the Amova Global Shares Hedged Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

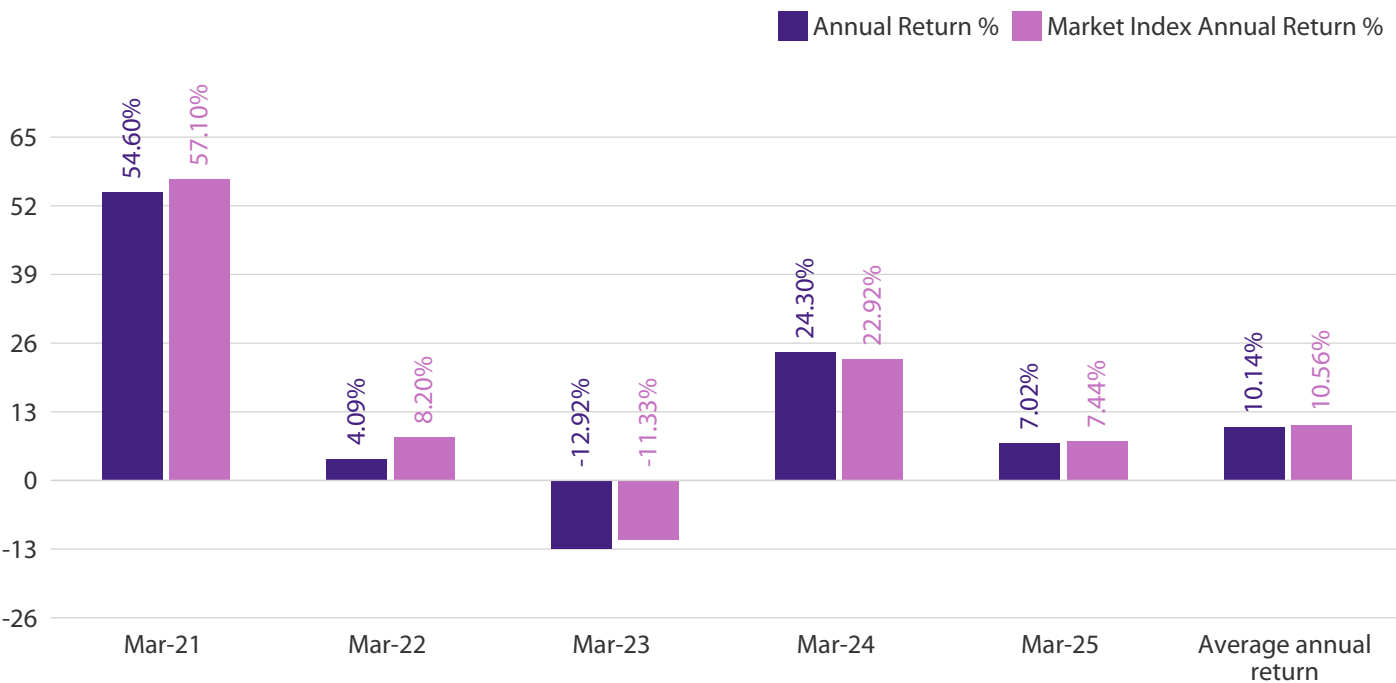
How has the fund performed?

Example of how this applies to an investor

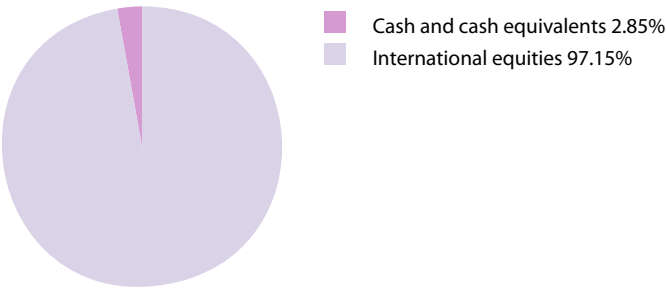
Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam received a return after fund charges were deducted of \$1,082 (that is 10.82% of his initial \$10,000.00). Sam also paid no other charges. This gives Sam a total return after tax of \$973 for year.²
