What is the purpose of this update?


Description of this fund

The Fund aims to achieve a return which exceeds the benchmark return by 1.00% p.a. over a rolling three-year period before fees, expenses and taxes. The Fund invests across a range of actively managed funds to create a diversified portfolio with a focus on lower risk assets.

What are the risks of investing?

Risk indicator for the GoalsGetter Amova Conservative Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?

Annual Return Graph¹



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2025.

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam received a return after fund charges were deducted of \$568 (that is 5.68% of his initial \$10,000.00). Sam also paid \$30 in other charges. This gives Sam a total return after tax of \$425 for the year.²


What does the fund invest in?
