What is the purpose of this update?

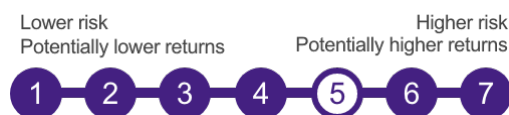
Description of this fund

The fund aims to outperform the MSCI All Countries World Index, with net dividends reinvested, expressed in NZD (unhedged) by 3.0% p.a. over a rolling three-year period before fees, expenses and taxes. The fund seeks to provide investors with a relatively concentrated actively managed investment portfolio of global equities to achieve long term capital growth.

What are the risks of investing?

Risk indicator for the GoalsGetter Amova Global Shares Fund

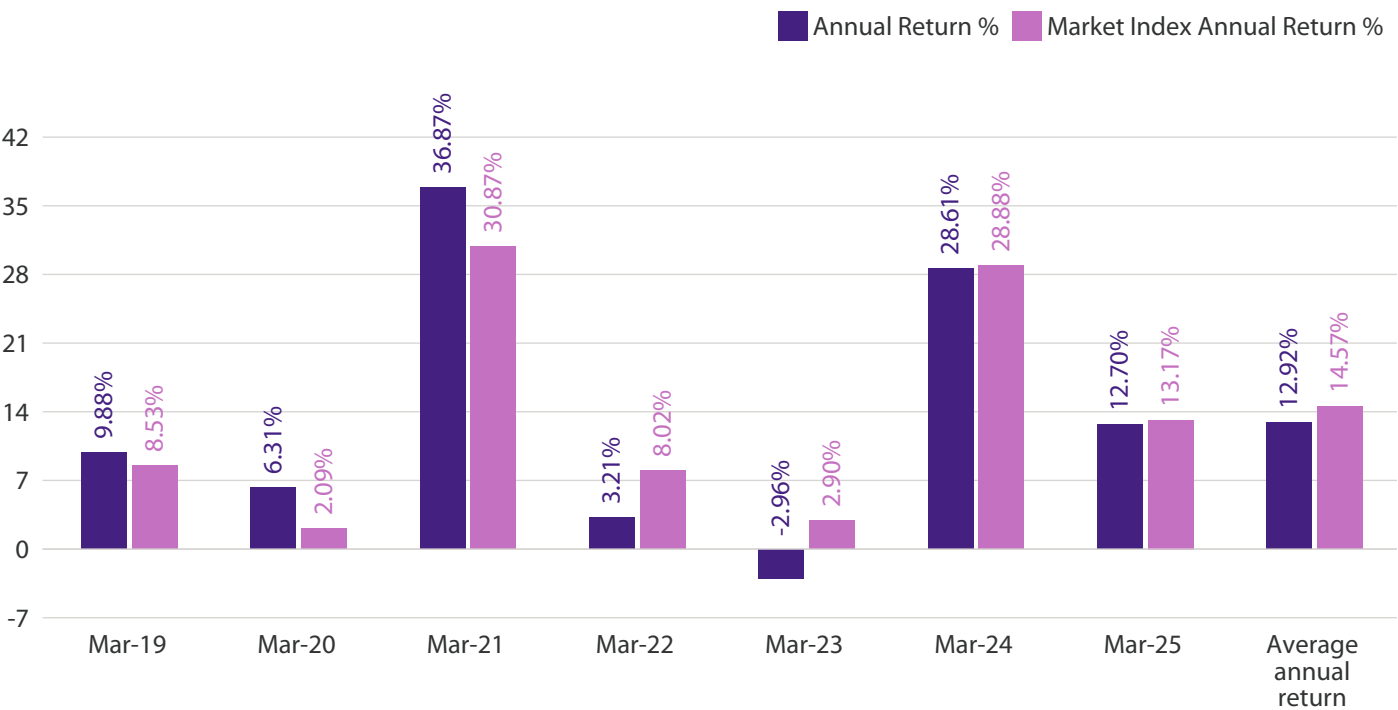
How has the fund performed?

This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2025.

Example of how this applies to an investor

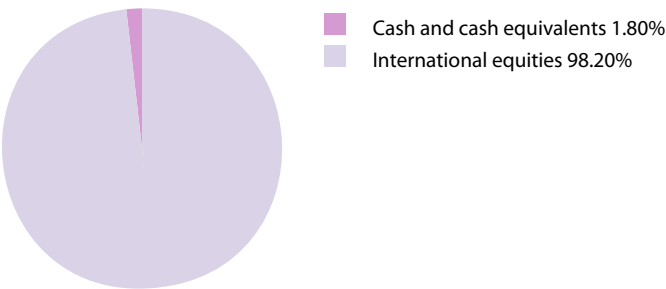
Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam received a return after fund charges were deducted of \$770 (that is 7.70% of his initial \$10,000.00). Sam also paid \$30 in other charges. This gives Sam a total return after tax of \$640 for the year.²
