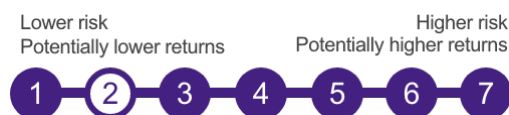
Description of this fund

The fund aims to outperform the Bloomberg NZ Bond Bank Bill Index by 0.20% p.a. over a rolling three-year period before fees, expenses and taxes. The fund aims to provide investors with regular income by constructing an actively managed investment portfolio of short-term deposits and bonds whilst preserving capital value.

What are the risks of investing?

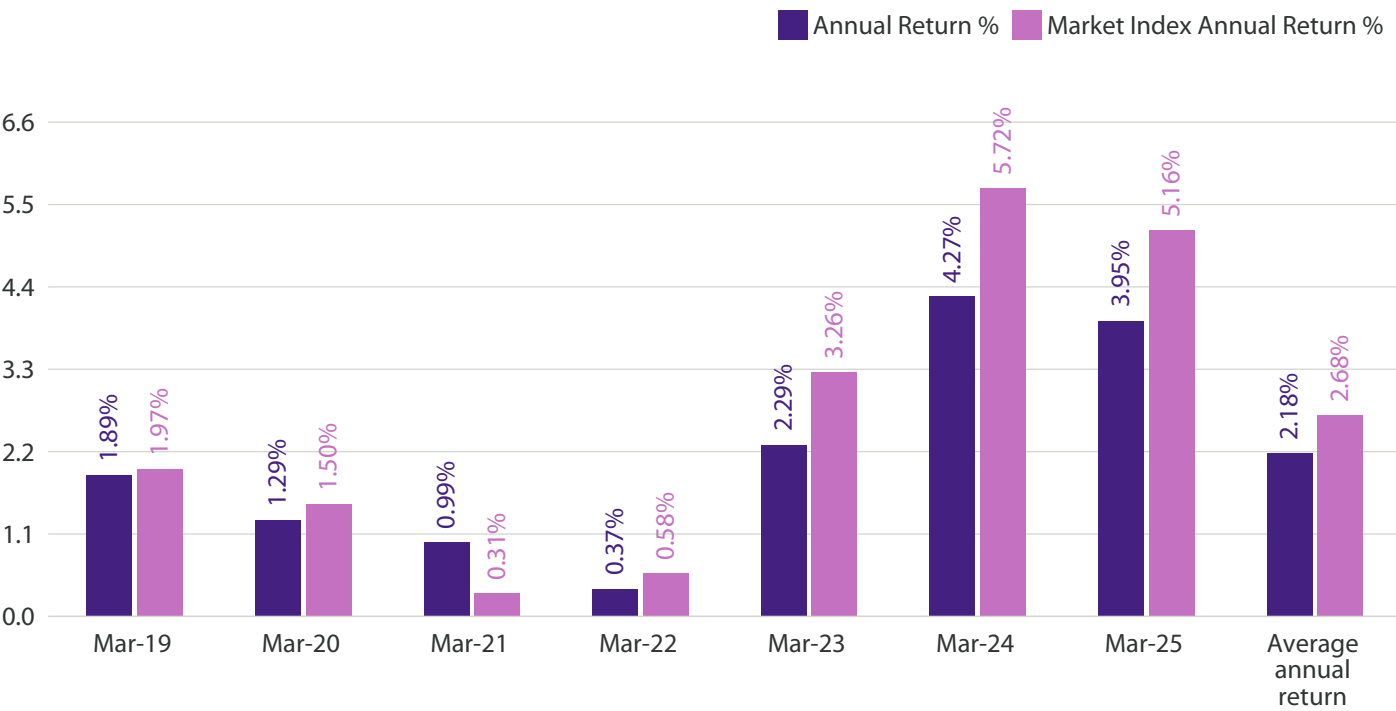

Example of how this applies to an investor

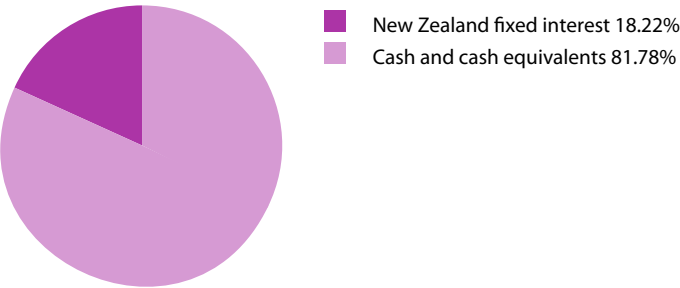
Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam received a return after fund charges were deducted of \$372 (that is 3.72% of his initial \$10,000.00). Sam also paid \$30 in other charges. This gives Sam a total return after tax of \$234 for the year. ²
