

Amova Global Equity Multi-Manager Hedged Fund

Fund Update: Quarter 4/2025 ending 31 December 2025

What is the purpose of this update?

This document tells you how the Amova Global Equity Multi-Manager Hedged Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Amova NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund aims to outperform the MSCI All Countries World Index (net dividends reinvested), hedged 100% to the New Zealand Dollar by 3.0% p.a. over a rolling three year period before fees, expenses and taxes. This fund aims to provide investors with long term growth from an actively managed investment portfolio selected from global equity markets with currency exposure created as a consequence of global equity investment hedged 100% to the New Zealand Dollar.

What are the risks of investing?

Risk indicator for the Amova Global Equity Multi-Manager Hedged Fund

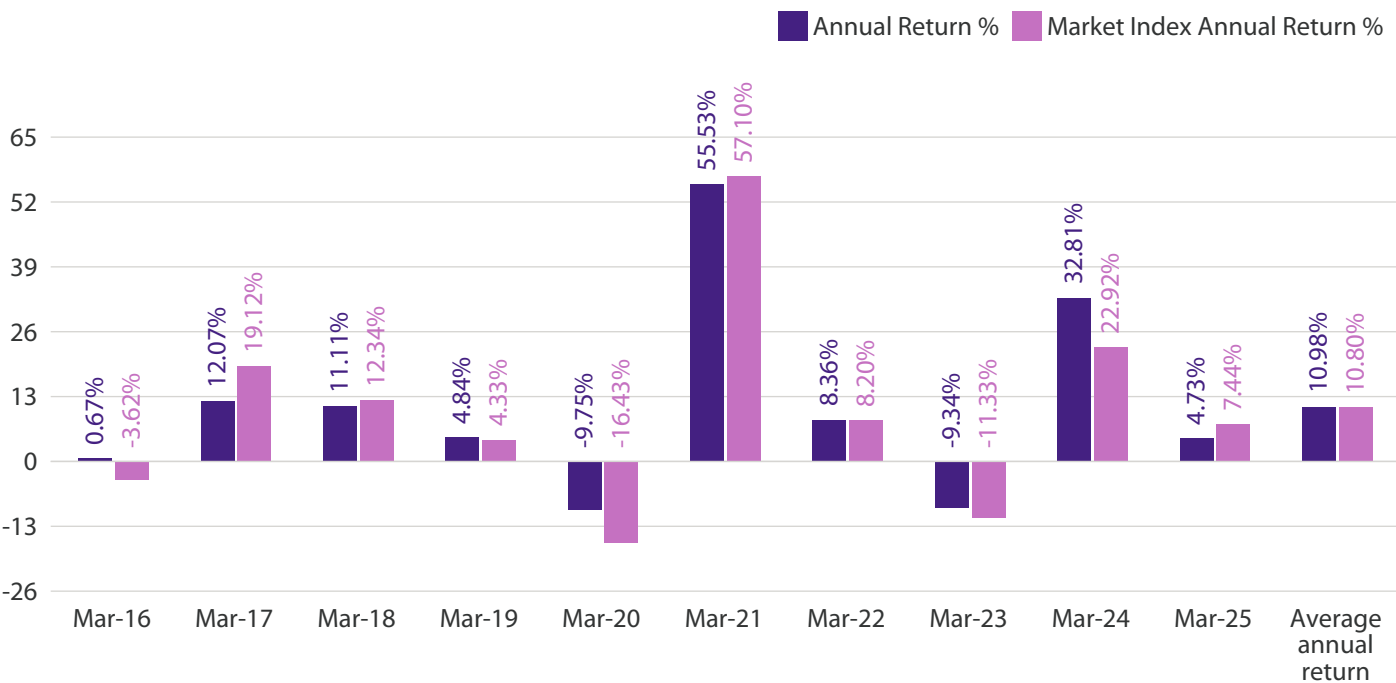
How has the fund performed?

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam received a return after fund charges were deducted of \$1,297 (that is 12.97% of his initial \$10,000.00). Sam also paid no other charges. This gives Sam a total return after tax of \$1,193 for the year.²

The total value of the top 10 investments makes up 48.53% of the net asset value of the fund.
