What is the purpose of this update?

This document tells you how the GoalsGetter Milford Aggressive Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Amova NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

A diversified fund that primarily invests in international equities, with a moderate allocation to Australasian equities. Objective is to maximise capital growth*over the minimum recommended timeframe.

What are the risks of investing?

Example of how this applies to an investor

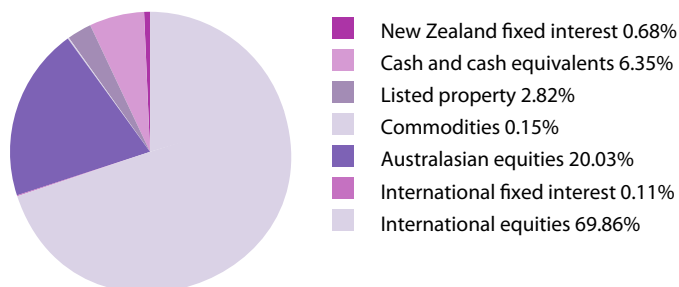
Small differences in fees and charges can have a big impact on your investment over the long term.

Sam made the first investment of \$10,000 in the fund when the fund started and did not make any further contributions. As at 31 March 2026, Sam incurred a loss after fund charges were deducted of \$302 (that is -3.02% of his initial \$10,000.00). Sam also paid \$22.50 in other charges. This gives Sam a total loss after tax of \$335 for period ending 31 March 2026.²

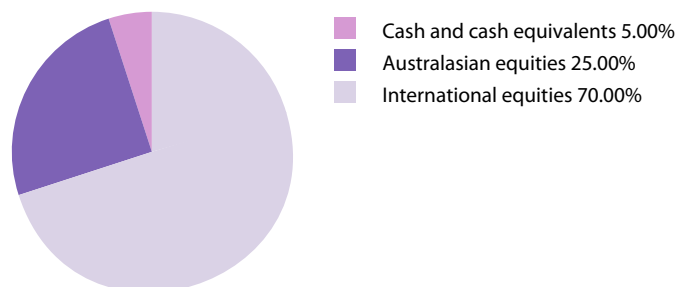
What does the fund invest in?

Notes

1. Because the fund is less than five years old, the risk indicator uses returns data partly from returns of the fund, and partly (for the period April 2021 - June 2025) from the composite index.
