What is the purpose of this update?

This document tells you how the GoalsGetter Pathfinder Ethical Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Amova NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

An ethical portfolio invested in growth and income assets. The fund undertakes ethical investing to achieve medium to high returns with a higher risk focus.

What are the risks of investing?

Risk indicator for the GoalsGetter Pathfinder Ethical Growth Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

What fees are investors charged?

Investors in the GoalsGetter Pathfinder Ethical Growth Fund are charged fund charges. In the year to 31 March 2026, these were (inclusive of GST where applicable):

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). Other management and administration charges includes a 0.05% estimated external costs. This is an estimate of charges the underlying Manager may incur for investing in other funds.

Example of how this applies to an investor

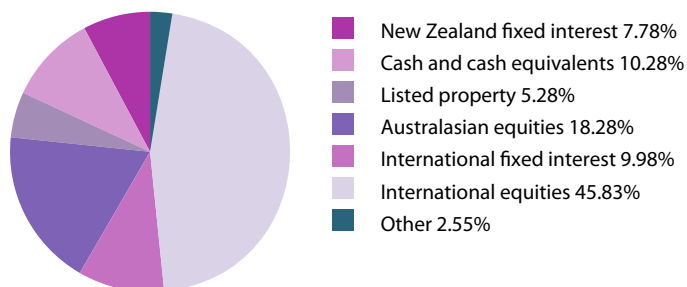
Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam received a return after fund charges were deducted of \$713 (that is 7.13% of his initial \$10,000.00). Sam also paid \$30 in other charges. This gives Sam a total return after tax of \$635 for the year.²

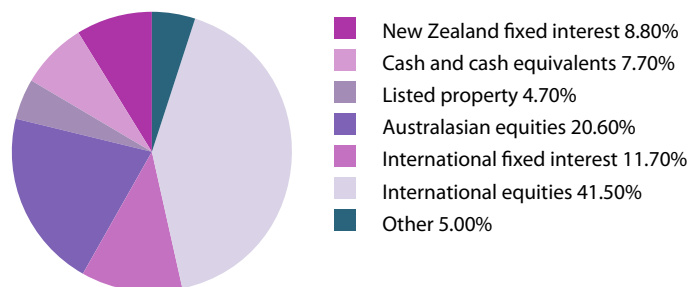
What does the fund invest in?³

Notes

1. Because the fund is less than five years old, the risk indicator uses returns data partly from returns of the fund, and partly (for the period April 2021 - May 2024) from the composite index. As a result of this, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.
2. For the purpose of this example, the start of the year is 1 April 2025.
3. Actual and target investment mix are for the underlying fund our fund invests in.
4. All investments in this fund update are described in New Zealand dollars.
