

GoalsGetter Salt Capital Growth Fund

Fund Update: Quarter 1/2026 ending 31 March 2026



What is the purpose of this update?

This document tells you how the GoalsGetter Salt Capital Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Amova NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund aims to outperform the Reserve Bank of New Zealand's Consumer Price Index +5% p.a. benchmark (after fees and expenses but before tax) on a rolling five-year basis by investing in a diversified mix of growth and defensive assets with a focus on securities with high ESG factor scores.

Effective 9 July 2025, the Fund changed its name to the GoalsGetter Salt Capital Growth Fund. This was due to the change of name of the underlying fund that this fund invests in. (Salt Capital Growth Fund, formerly the Salt Sustainable Growth Fund.)

What are the risks of investing?

Risk indicator for the GoalsGetter Salt Capital Growth Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

Example of how this applies to an investor

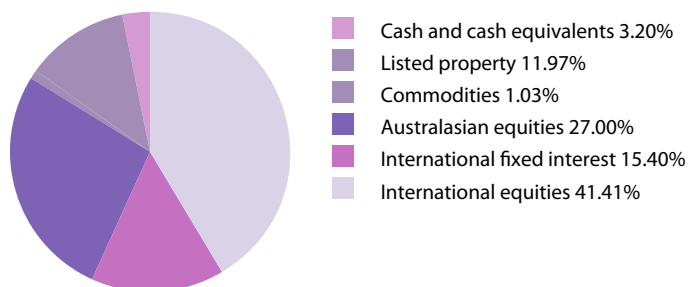
Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam received a return after fund charges were deducted of \$60 (that is 0.60% of his initial \$10,000.00). Sam also paid \$30 in other charges. This gives Sam a total loss after tax of \$68 for the year.²

Notes

1. Because the fund is less than five years old, the risk indicator uses returns data partly from returns of the fund, and partly (for the period April 2021 - May 2024) from the composite index.
