What is the purpose of this update?

This document tells you how the Amova Global Equity Multi-Manager Hedged Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. 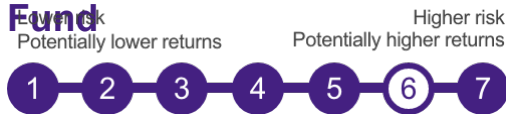
Description of this fund

The fund aims to provide investors with long term growth from an actively managed investment portfolio selected by four underlying managers. Each manager selects companies from around the world covering a diverse range of regions and sectors based on their own investment process. Currency exposure created as a consequence of global equity investment hedged 100% to the New Zealand Dollar. This fund has a very high level of volatility.

What are the risks of investing?

Risk indicator for the Amova Global Equity Multi-Manager Hedged Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

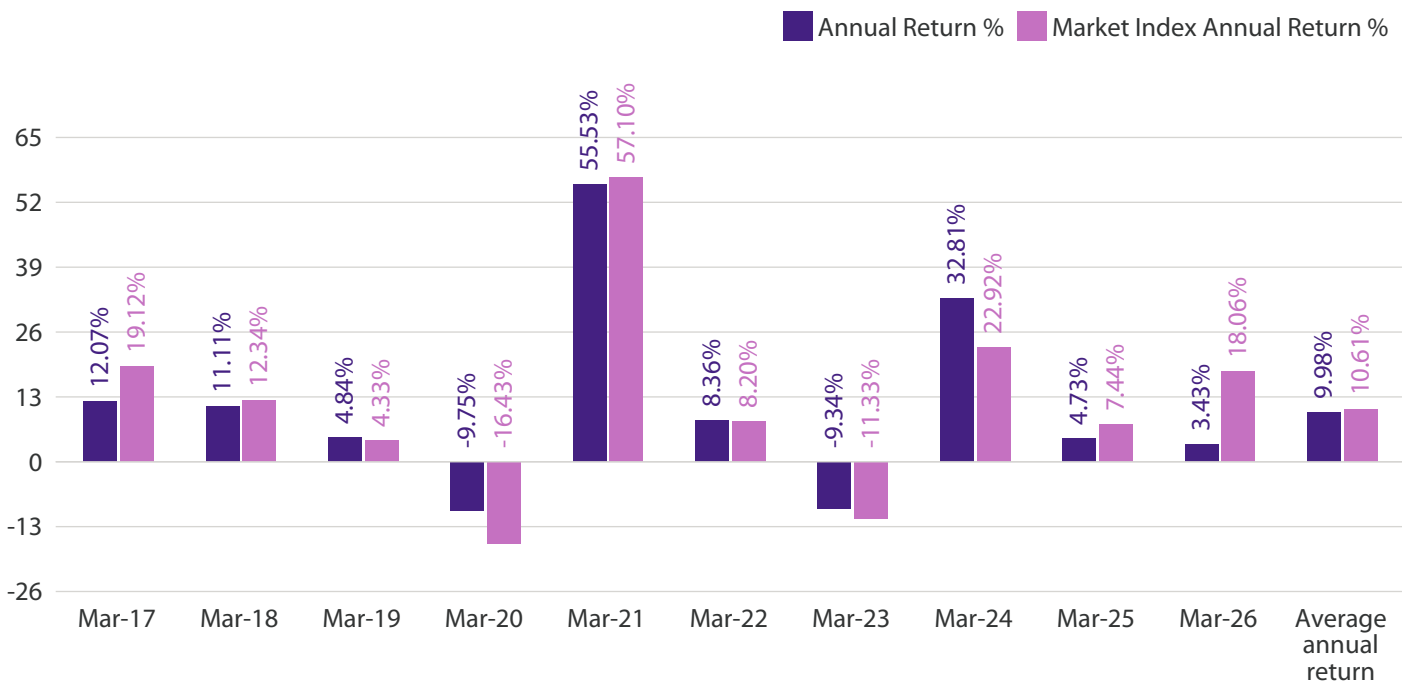
How has the fund performed?

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam received a return after fund charges were deducted of \$437 (that is 4.37% of his initial \$10,000.00). Sam also paid no other charges. This gives Sam a total return after tax of \$343 for the year.²

The total value of the top 10 investments makes up 52.25% of the net asset value of the fund.
