What is the purpose of this update?

This document tells you how the Amova Global Shares Hedged Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. 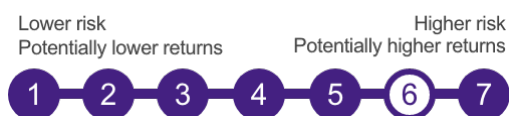
Description of this fund

The fund aims to provide investors with a relatively concentrated actively managed investment portfolio of global equities to achieve long term capital growth. This fund invests in a selection of around 40-50 companies from around the world, covering a diverse range of regions and sectors. Currency exposure created as a consequence of global equity investment hedged to the NZD. This fund has a very high level of volatility.

What are the risks of investing?

Risk indicator for the Amova Global Shares Hedged Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

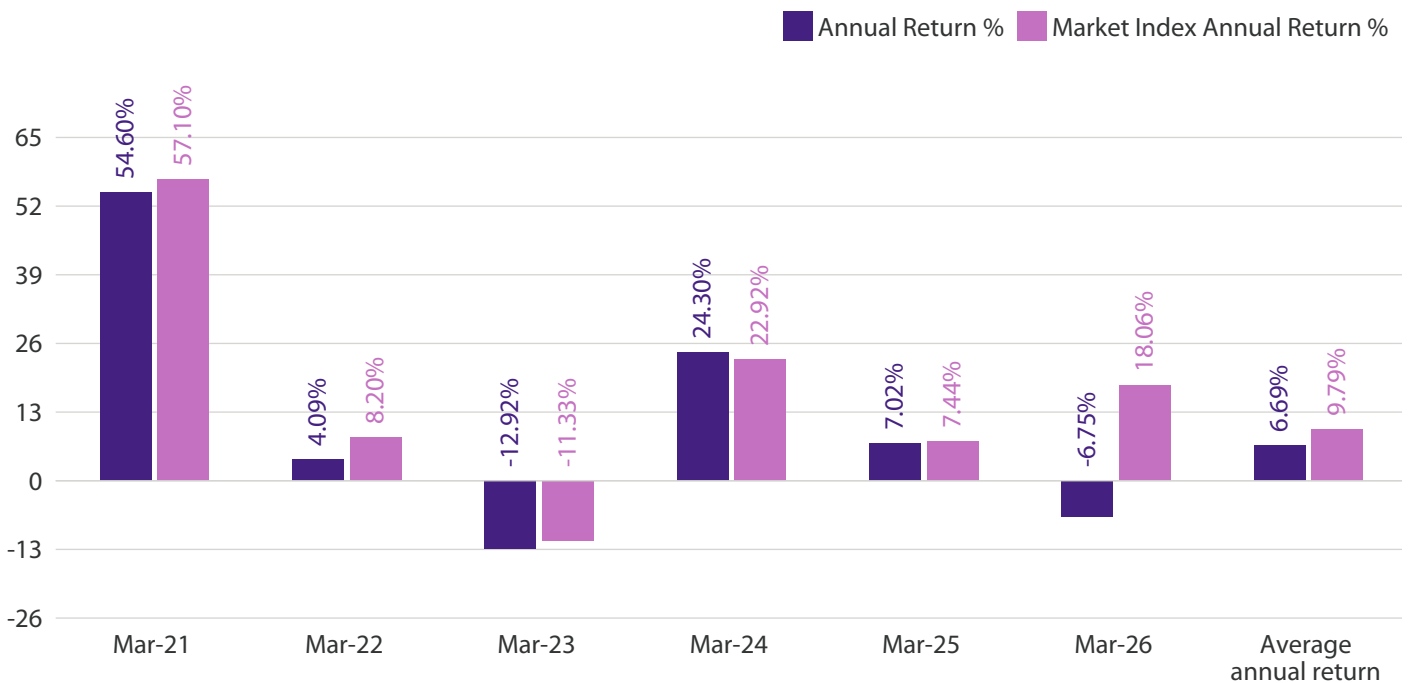
How has the fund performed?

This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 March 2026.

Example of how this applies to an investor

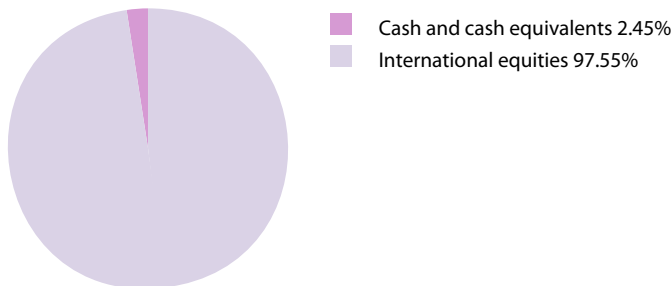
Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam incurred a loss after fund charges were deducted of \$586 (that is -5.86% of his initial \$10,000.00). Sam also paid no other charges. This gives Sam a total loss after tax of \$675 for the year.²

The total value of the top 10 investments makes up 41.44% of the net asset value of the fund.
