Fund Update: Quarter 1/2026 ending 31 March 2026

What is the purpose of this update?

This document tells you how the Amova NZ Corporate Bond Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Amova NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund aims to outperform the Bloomberg NZBond Credit 0+ Year Index by 0.70% p.a. over a rolling three year period before fees, expenses and taxes. The fund aims to provide investors with regular income by constructing an actively managed investment portfolio of New Zealand bonds, deposits and cash whilst preserving the capital value.

What are the risks of investing?

Risk indicator for the Amova NZ Corporate Bond Fund

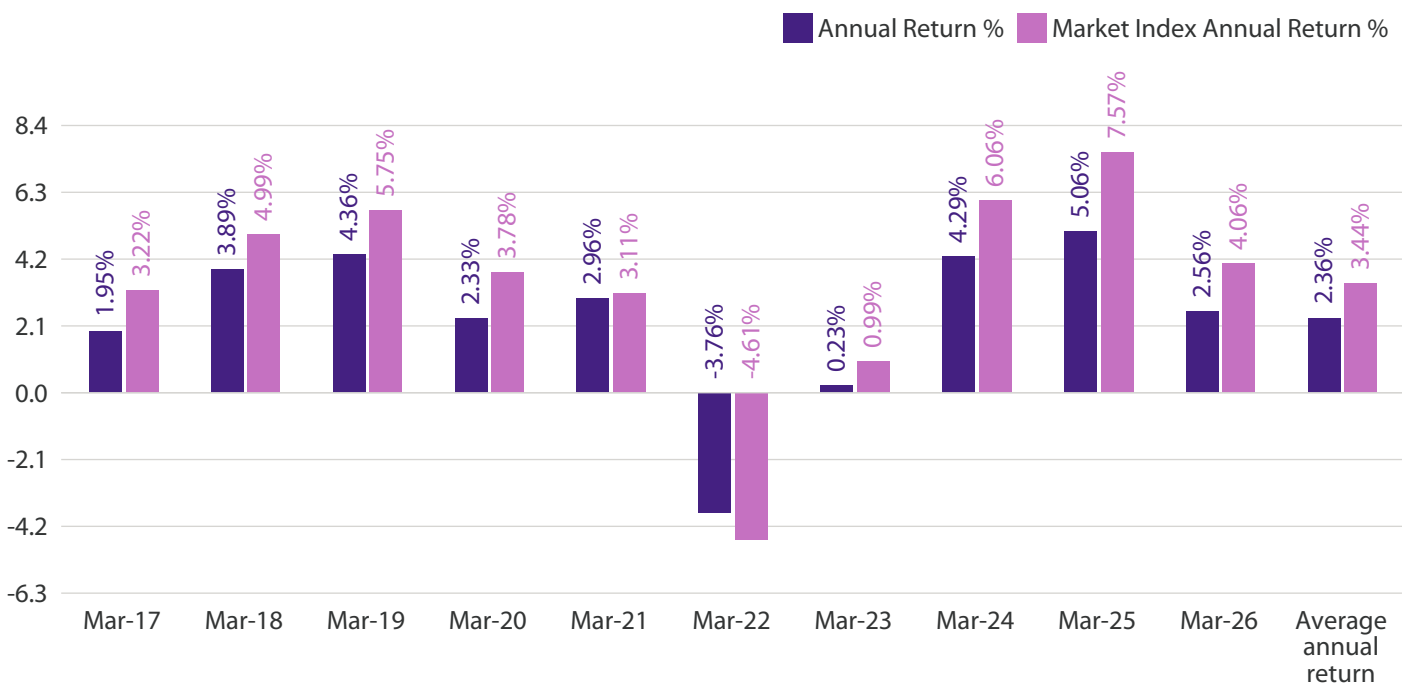

Example of how this applies to an investor

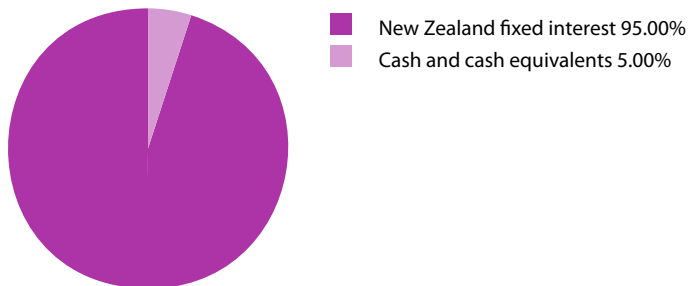
Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam received a return after fund charges were deducted of \$358 (that is 3.58% of his initial \$10,000.00). Sam also paid no other charges. This gives Sam a total return after tax of \$256 for the year.²
