Fund Update: Quarter 2/2026 ending 30 June 2026

What is the purpose of this update?

This document tells you how the Amova Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Amova NZ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund aims to achieve a return which exceeds the benchmark return by 1.00% p.a. over a rolling three- year period before fees, expenses and taxes. The Amova Conservative Fund invests across a range of actively managed funds to create a diversified portfolio with a focus on lower risk assets.

What are the risks of investing?

Risk indicator for the Amova Conservative Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

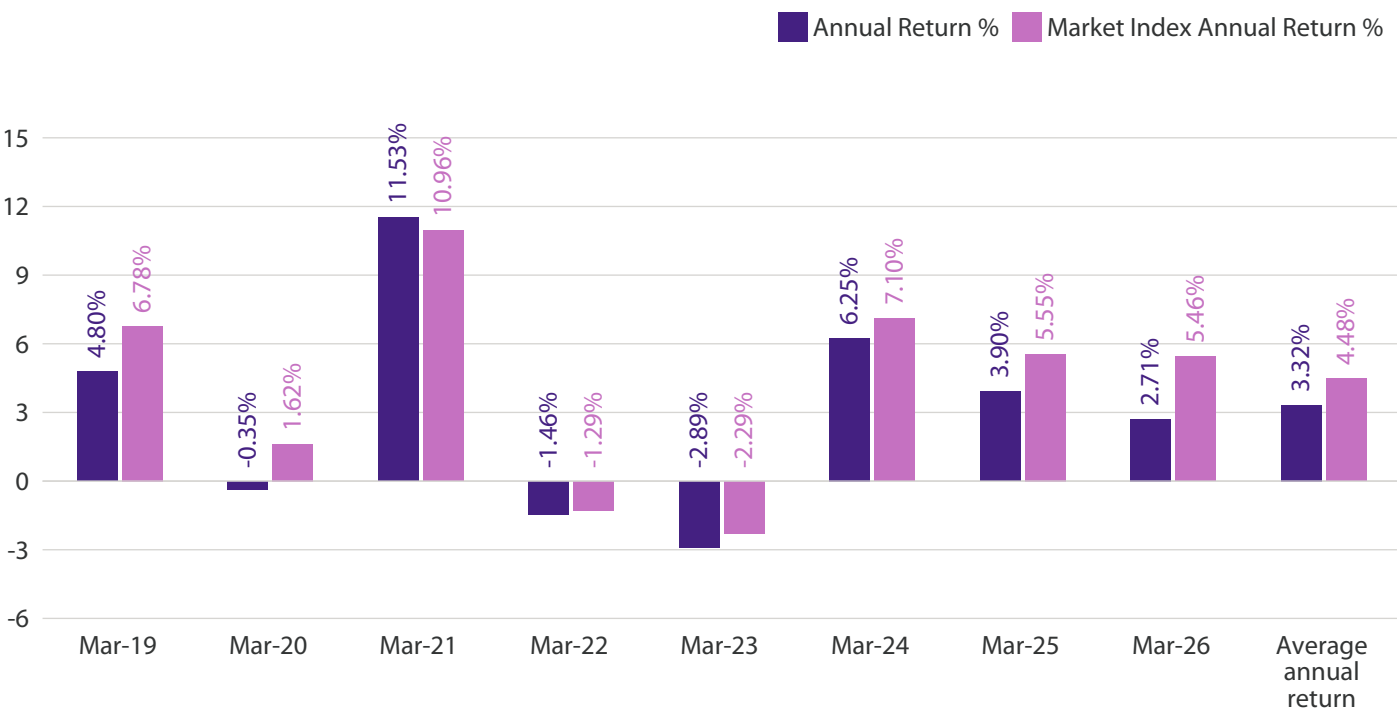
How has the fund performed?

Annual Return Graph¹



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 June 2026.

Example of how this applies to an investor

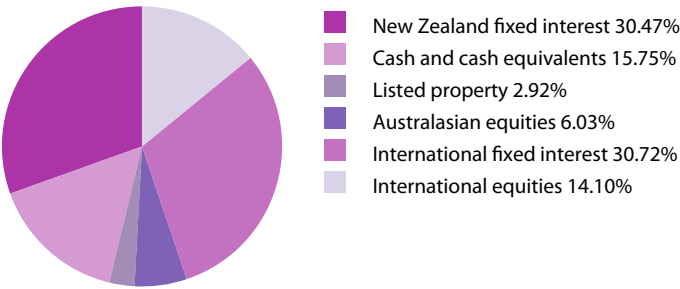
Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam received a return after fund charges were deducted of \$531 (that is 5.31% of his initial \$10,000.00). Sam also paid no other charges. This gives Sam a total return after tax of \$426 for the year.²

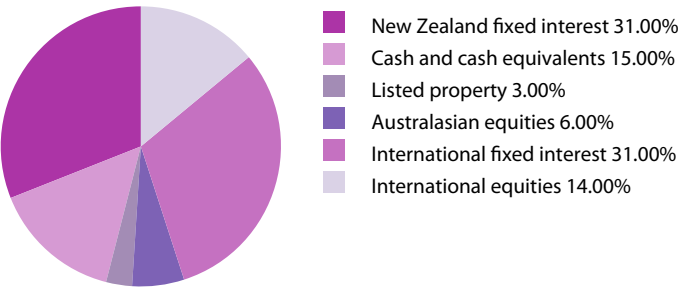
What does the fund invest in?
